Trainer Institute

- To provide training that imparts practical knowledge and skills.
- To mentor and supervise students during the internship period

Trainee Institute

- To facilitate communication and coordination between the students and the Trainer Institute.
- To ensure students adhere to the guidelines and responsibilities during the internship.

Duration of the MoU

This MoU shall remain valid for a period of 45 days, commencing immediately after the conclusion of the 4th semester examinations.

Location of the Training Program

The training activities under this MoU may be conducted at the premises of the Trainer Institute or at a location mutually agreed upon by both parties.

Amendment Clause

Any modifications or amendments to this MoU shall be made through mutual consent in writing, signed by authorized representatives of both the Trainer and Trainee Institutes.

Entire Agreement

This MoU represents the entire understanding between the two institutions. Any future agreements or understandings shall be documented separately and signed by both parties.
